Liability Waiver

I attest that I am the parent/guardian of the individual listed below. As lawful consideration for my child being permitted to participate in the National Middle School Duals (NMSD), hosted by the Genoa Wrestling Club, I agree that neither myself nor anyone associated with my child will make a claim against, sue, attach the property of or prosecute the NMSD, sponsors, venue, and all others associated with the event for damage, for death, personal injury or property damage which my child may sustain as a result of my child's participation. This release is intended to discharge in advance all members of the National Middle School Duals, sponsors, venue, and all others associated with the event against all liability, including negligent actions, arising out of or connected in any way with the child's participation. I further understand that wrestling involves physical contact between players, that serious accidents occasionally occur during such physical activity, and those participants in such sporting events occasionally sustain serious personal injuries (including death) and/or property damage as a consequence. Knowing the risk of participation, nevertheless, I hereby agree that my child/ward and I assume those risks and release and hold harmless, the NMSD, sponsors, venue, and all others associated with the event, who (through negligence or carelessness) might otherwise be liable to me for damages.

Infectious Disease Wavier

I attest that I am the parent/guardian of the individual listed below. As lawful consideration for my child being permitted to participate in the National Middle School Duals (NMSD), hosted by the Genoa Wrestling Club, I understand, acknowledge and agree that:

1. Participation in such events or activities by my child and/or myself involves possible exposure to and illness from infectious and/or communicable diseases including, but not limited to, COVID-19, MRSA, Influenza, and other communicable diseases. While adherence to rules and requirements may reduce the risk of possible exposure, the risk of serious illness and death remains; and
2. On behalf of my child and/or myself, I knowingly and freely ASSUME ALL SUCH RISKS, both known and unknown, even if arising from the negligence of the releasees of others, and assume full responsibility for my participation; and
3. On behalf of my child and/or myself, I agree to comply with all rules, regulations or conditions established by the NMSD and the State of Ohio for participating in such events or activities; and
4. On behalf of my child and/or myself, I for myself and on behalf of my heirs, assigns, personal representative and next of kin, HEREBY RELEASE AND HOLD HARMLESS the NMSD, sponsors, venue, and all others associated with the event ("RELEASEES"), from and against any and all claims of whatever type or kind including any illness, death, disability, or other loss or damage to personal property, whether arising from the negligence of Releasees or otherwise to the fullest extent permitted by law. Further, I expressly agree that this release is intended to be as broad and inclusive as permitted by the laws of the State of Ohio or any other state in which my child and/or myself may participate in any event or activity described herein, and that if any portion of this release is determined to be invalid, it is agreed that the remaining provisions of this release shall continue in full force and effect. Finally, I further state that I have fully and carefully read the above release, understand the contents of the same and sign this release voluntarily as of my own free act and deed.

Event COVID Compliance Guidelines Acknowledgement

I attest that I am the parent/guardian of the individual listed below. As lawful consideration for my child being permitted to participate in The National Middle School Duals, I understand, acknowledge and agree to the following:

- The event will be limited to 9 spectators per team to comply with State of Ohio indoor spectator limits.
- Teams will be limited to 20 wrestlers per team, no more than two per weight class, two coaches and one table worker.
- Each team will provide a table worker for each dual. No tappers. Tables will be sanitized between workers.
- Spectators, coaches, wrestlers and workers will adhere to their home states, out of state travel and quarantine guidelines.
- If a wrestler, coach, spectator or worker feels sick or are experiencing any symptoms pertaining to COVID-19, it must be reported to the Tournament Director immediately at the head table or by calling 419-277-3780 after event hours.
- Temperatures will be taken for wrestlers prior to weighing in. If a temperature is 100.4 and higher, that individual and whomever they came with, will be sent home.
- Temperatures will be taken for anyone entering the event, before each session. If a temperature is 100.4, that individual and whomever they came with, will be sent home.
- *Liability Waiver and Infectious Disease Wavier* must be signed and on file with the Tournament Director prior to participating.
- Masks must always be worn by all workers and spectators. All athletes must wear a mask unless they are considered "Wrestling," "On Deck," or "In the Hole." If you are not adhering to this guideline, you will be asked to leave.
- Health questions may be asked to anyone entering the event. This is including but not limited to coaches, wrestlers, event workers/volunteers/sponsors and spectators. Please refer to the Ohio Dept of Health website for their preferred list of questions that we will be using.
- All workers, spectators, athletes, and coaches must use the accessible hand sanitization stations located throughout the event area consistently.
- Only two people allowed in the restrooms at a time or appropriate social distancing is required.
- Maintain social distancing markings at the concession stand area and gear store area.
- Common areas of touch throughout the event area will be sanitized throughout the day.
- Bathrooms and other common areas will be cleaned regularly by event staff. The tournament workers will inspect the bathrooms and other common areas during the event to determine the need for additional cleaning.
- Weigh-ins will be limited to wrestlers only. Masks will be worn but removed for skin check if needed. There will be no working out in the event hall, weigh-in area or lobby area.
- At mat side, chairs will be available for coaches and wrestlers. Chairs will be distanced and must stay in the marked area to adhere to social distancing.
- There are to be no handshaking prior to matches, hand raising after a match is won, or shaking of hands after matches or dual completion.
- Mats and Table Equipment will be sanitized before and after each day of the event and in between rounds.
- No personal belongings or street shoes are allowed on the mats.
- No wrestling shoes are to be worn outside of the building.
- Athletes will clean wrestling shoes in the bleach trays before stepping on/off the mat.
- The athlete must clean up their own bodily fluids.
- Athletes will wipe down with sanitary wipes before leaving the mat after their match is completed.
- After each round, the teams will be released to their next mat or waiting area.
